Forty Years Ago... How It All Began

Mad River, Ruth Lake and surrounding areas have beautiful mountains, a gorgeous lake, beautiful forests with hiking and riding trails, fields of wildflowers and two local refreshing rivers (Van Duzen River and Mad River). Now imagine living, working or vacationing in this beautiful community without emergency services. What would you do if your child, spouse, parent, friend, neighbor, or someone not known to you needed immediate medical attention? In researching the history (Southern Trinity Tribune), talking with folks that lived or still live out here, of the many times people tried to help unsuccessfully was heart breaking. They would say: "back in the 70's you would hope someone would come by with a pickup and that they would make it to town alive!" The wait time for an ambulance depended on their location, in the woods, off the road in a ditch, at the lake or an outlying community (Hetten Valley or Zenia). It could take anywhere from 90mins to 3+ hours to get help! If the weather was bad, it could extend the wait time or be cancelled! Even with local help, if the person was not properly trained in emergency medical services, the result of unintentional additional harm or tragedy could occur. In 1977 California Legislator's passed a bill which would provide funds for rural health clinics. The need was great here and three community members, Russ Frasier, Dan Gordon and Andy Gough, rose to the task volunteering to get the application process started. First was the task of becoming a nonprofit 501C3, in order to be eligible for funding. The travel

Expenses, consultant fees, etc., to get this process going was funded by the Six Rivers Lions Club. Upon submission for EMS funding, they were told that the State would provide such funding only if it were within a primary care facility. In order to continue, the second task was to create a formal medical plan for the underserved in the area. With the help from an advisory committee (Don Bridge, Mavis Brown, Irene Stapp, to name a few), community members, Supervisors from Trinity and Humboldt Counties. members of the State Department of Health, representatives from ambulance companies, North Coast EMS and many others, it took months to work out a plan. Through their tireless efforts. Southern Trinity Health Services (STHS) was born. Its first priority was emergency care, second was education (public training programs in 1st aid, CPR and eventually EMT), third was to establish a local clinic that would serve as a base for the emergency and training operations and also be available as a year round medical center for routine care. Finally the application moved through the approval stages and in the spring of 1978 final approval was received! However, actual funding was far from being received. Now STHS was told by the State, an operating program was needed to receive operating funds. The Ruth Riding and Roping Club came to the rescue with a loan of \$5000 to get the project underway. The next hurdle was getting a building to rent or own, which was solved by the Trinity County Board of Supervisors! Our then County Supervisor, George Wilburn, convinced the BOS to purchase a mobile building and lease it to STHS. But wait, now where are they going to put the building? The Ruth Lake Community Services District came to the rescue, by leasing a part of their leased property that is owned by Southern Trinity Unified School District. In late summer of 1978, construction began with volunteers. STHS opened its doors with basic medical care in November 1978 and the training of STAR volunteers began and continues to this day. Here, in our local community, is where caring people without medical knowledge, got together to start an EMS service. where community organizations stepped up with support, where neighbor helped neighbor and volunteering took hold and still holds our STAR organization together today. This summer I will continue the celebration of our 40th Anniversary with more articles, a picture of the first ambulance (a 1978 Chevy Suburban), how fishing tackle boxes were used to carry 1st aid supplies and the emergencies that STAR responded to in the early days. A huge thank you to the following people that helped me gather this information; told of their stories and encouraged me to write this article of "How it all began": Danene Bates, Claudette Bushman, Shirley Dillon, Brooke Entsminger, Jean German, Susan Gordon, Mark Middleton, Jack Rogers, Dottie Simmons.
